We are pleased to invite you to contribute to the very first issue of the newly-launched journal published by the Serbian Association for the Study of English, The SASE Journal.

The SASE Journal is an open access, double blind peer-reviewed journal that publishes research papers dedicated to issues in the broadly-defined areas of English linguistics, literature, and culture. It will predominantly appear in an online format once a year, in December. The SASE will provide space for its electronic release on the SASE webpage and support the publication of a limited number of print issues.

The journal aims to serve as an accessible platform for the exchange of information and ideas, catering to a comprehensive audience of researchers, educators, and practitioners alike. To enable rapid dissemination of scholarly information, the journal will be offering authors the opportunity for advance online publication of their submissions as soon as they have passed the review process.

The journal welcomes a variety of previously unpublished manuscripts: traditional 'full-length' articles based on empirical or theoretical data, meta-analyses, case studies, review papers, brief reports, and book reviews. Proposals for special issues that center around an under-researched or emerging topic of interest are more than welcome and can be discussed with the Editors (thesasejournal@filfak.ni.ac.rs).

We would be truly honored if you could make a personal contribution to the first issue of our journal. The papers, written in English, are to be submitted electronically no later than September 1, 2024 to the email address thesasejournal@filfak.ni.ac.rs.

## A Guide for Authors

First of all, thank you for considering The SASE Journal as a channel for publication of your manuscript. Your contribution is greatly appreciated.

Papers should be submitted in MS Word format to the email address thesasejournal@filfak.ni.ac.rs. Please use Times New Roman, font size 12 for the abstract, main text and quotations; also, use single line spacing. Given that manuscripts are to be submitted solely in English, they should be carefully proofread before submission. American English or British English spelling conventions should be observed consistently. Manuscripts must be original. In other words, they must not have been published previously or submitted for publication, in the same or (slightly) different form, elsewhere (a journal, book of proceedings, etc.).

Original manuscripts should not exceed the maximum limit of **7,000 words** in length, excluding the abstract and references. Book reviews should not exceed the maximum limit of **2,000 words**. Please use footnotes and endnotes sparingly. Footnotes should contain additional information, not whole paragraphs devoted to a critical examination or debate. Acknowledgements of financial support or expressions of gratitude (to reviewers, data collection assistants, etc.) should be provided on the first page of the text in a footnote.

The first page of the manuscripts should provide the following information about the author(s):

- Name(s) of the author(s)
- Affiliation(s) of the author(s)
- Email address(es) of the author(s)
- Corresponding address
- ORCID number(s) of the author(s)

The general structure of the papers should be:

- 1. Paper title
- 2. Abstract (150-250 words)
- 3. Keywords (up to five)
- 4. Main text divided into sections and subsections
- 5. References

## The titles and subtitles should be listed as follows:

- 1. Title
- 1.1. Subtitle one
- 1.2. Subtitle two

In-text citations should be provided in the following manner:

If two or more works are to be cited in the same parentheses, list them in alphabetical order and separate them by a semicolon.

Several studies (Bauer, 2023; Mattiello, 2019; Plag, 2003) suggest that...

Quotations should be provided by means of double quotation marks.

As Bauer (2023: 1) noted "[i]t is often not clear whether any given word containing the affix is borrowed as a unit or whether the affix is added in English".

Longer quotations (more than 3 lines) should be indented from both the left and the right margin with a blank line above and below:

Language change, whether it involves alterations to words, meanings, sounds, or grammatical structures, leaves behind in its debris a partial history of the language. For example, linguistic curiosities like *foot-feet* and *tooth-teeth* date back to a pronunciation feature of early English. This involved a kind of vowel harmony known as 'umlauting'. (Burridge, 2002: 79)

All references cited in the main text must appear in the list of references and vice versa.

The list of references should be composed in the following manner:

 Entries should be arranged in alphabetical order. If you cite several works by the same author, his/her single-authored publications should precede their co-authored ones even if the latter precede the former.
